



# All-Day Kindergarten FAQ

## 1. How do I register for all-day kindergarten? It's as easy as 1-2-3!

**Step 1: Online Registration for Kindergarten** opens on February 12, 2021. You may access and complete registration forms on the District and Evamere Elementary websites at [www.hudson.k12.oh.us/kindergartenreg](http://www.hudson.k12.oh.us/kindergartenreg). Note: A child must be 5 years old by September 30, 2021, to qualify for Kindergarten.

**Step 2: Documents for Registration:** All registration documents need to be uploaded and online registration completed by **March 12**. There are multiple documents required for registration. Please be prepared to have the following documents ready to upload to complete online registration:

- Your child's original birth certificate
- Proof of residency (i.e. lease/rental agreement, purchase agreement, deed or title). We do not accept a driver's license, utility bills, or other personal identifiers.
- Applicable custody documents.

By law, a copy of your child's current immunization record and original state certified Birth Certificate are required. A copy of a Custody Statement is required if a child does not reside with both natural parents. An up-to-date Immunization Record is required on the first day of school. It is optional to provide a dentist's report.

**Step 3: Kindergarten Screenings** will take place on May 4, 5, or 6, 2021. You will receive an email after March 12th with more information about Kindergarten Orientation and Kindergarten Screenings. Our hope is to have in person screening, however, if this is not possible we will communicate a virtual option. The email will be coming from @hudson.k12.oh.us address.

## 2. What is the cost of all-day kindergarten?

The tuition for all-day kindergarten is \$3,600.00. There is a \$200.00 non-refundable deposit and then two payments of \$1,700.00 which are due prior to each semester. There is also an option to make four payments, or a single full-year payment. (See question 6 for details)

## 3. Do I have to make a deposit?

Yes. A \$200.00 non-refundable deposit is due by March 12. Please send a check made payable to Hudson City Schools to Evamere Elementary School at 76 North Hayden Parkway Hudson, Ohio 44236. The deposit, along with the completed registration information, **guarantees** a place in all-day kindergarten class. This is the only way to guarantee a place in all-day kindergarten. The \$200.00 fee is non-refundable and this is part kindergarten tuition.

## 4. Am I guaranteed a spot in all-day kindergarten?

Yes, if you have made the \$200.00 deposit and completed Step 1 and Step 2 of the registration process by March 12, 2021.

## 5. What if I change my mind during the summer?

If you have registered for all-day kindergarten and want to change your decision, please contact the school office at 330-653-1226 or the Assistant Superintendent's office at 330-653-1217. The \$200.00 deposit is non-refundable. Your child will be placed in a half-day kindergarten classroom.

## 6. When is tuition due?

First semester tuition payment is due August 6, 2021 via check made out to Hudson City Schools. Second semester tuition is due December 3, 2021. *First Semester* tuition payments will be mailed to Evamere Elementary, 76 North Hayden Parkway, Hudson, Ohio 44236 ATTN: Kindergarten. Tuition payments after August may be made using our online payment system, MyPaymentsPlus, via credit card or electronic check, or to the school office. Please note, there is a service charge for paying online.

### Payment plan options:

We are pleased to be able to offer several payment plans:

- Full year payment of \$3,400.00 due August 6, 2021 (checks made out to Hudson City Schools)
- Two payments of \$1,700.00 each due August 6, 2021 and December 3, 2021
- Four payments:
  - \$850.00 due June 4, 2021 (checks made out to Hudson City Schools)
  - \$850.00 due August 6, 2021 (checks made out to Hudson City Schools)
  - : \$850.00 due October 1, 2021 (via MyPaymentsPlus.com or via check)
  - \$850.00 due December 3, 2021 (via MyPaymentsPlus.com or via check)

## 7. What happens if I do not make the tuition payments?

If tuition payment is not made on time, your child will be placed in a half-day kindergarten classroom for the remainder of the school year. Tuition payments are due according to the tuition schedule (see #6). The change from all-day to half-day kindergarten will be made at the end of a week to help to provide transition time and closure for the student.

## 8. If my child goes to half-day kindergarten, will she/he be behind when starting first grade?

We believe that extended learning time in a consistent environment is beneficial and want to provide that opportunity at Evamere for our families. Both all-day and half-day classes will cover the curriculum and the requirements of kindergarten. The all-day kindergarten class provides more time for development of these skills. The all day kindergarten program will also include art, music, p.e., and library each week. The teachers at Evamere have extensive knowledge of how children learn. No matter the kindergarten experience, our teachers will be able to meet the needs of your child.

## 9. What if I do not register my child until August?

If you are a current Hudson City School District resident, we strongly encourage you to register your child at the designated registration window of February 12-March 12. We will continue to accept all-day registration and deposits; enrollment is monitored constantly and how many sections of all-day kindergarten is linked directly to numbers and interest. The \$200.00 deposit is due immediately at the time of registration. The first tuition payment is due in full August 6, 2021, soon after you register your student.

## 10. My child is in all day kindergarten, and we realize it is not a good match. Will I have a refund?

If you decide to move your child from all day to half-day kindergarten due to academic or social emotional reasons you must notify the Evamere office by September 30th. The first half of the year, \$1,700 tuition payment, is not refundable. Families who have paid the full tuition amount will be refunded for the second semester which is January-June. The student will be placed in an a.m. or p.m. class based on District guidelines.

## 11. My child begins the year in half-day kindergarten and we would like them to move to all-day programming. What is the process for making this change?

Our kindergarten classes have been “full” or very close to our capacity at the start of each school year. There may not be an open spot if you are interested in moving your child after the school year begins. However, if there is space in the all-day classes, the move would need to be made by the end of the first grading period.

**12. My family qualifies for free/reduced lunch. How do I proceed registering my child for all-day kindergarten?**

**13. How will my child be placed in first grade if they do not attend all-day kindergarten?**

The principal is responsible for placing students in heterogeneous classrooms. Student reading and math data are analyzed, as well as learning styles and personalities, to create the best placement for our children. No matter their kindergarten experiences, students will be placed in all first grade classes.

**14. I would like to request a certain teacher. What is the procedure?**

Parent requests for a certain teacher are not part of the placement process. Your child will be placed in a classroom based on Parent Questionnaire and registration information.

**15. My child is on an Individualized Education Plan (special education services). How do I proceed in registering them for all-day kindergarten?**

You will follow the registration process. The IEP team will determine what special educational services are needed for your child. Families have a choice of all-day or half-day programming for their child. If families choose to attend full-day kindergarten, tuition rates and registration guidelines apply.

**16. Will my child be transported to and from all-day kindergarten?**

Yes. They will be routed with their neighborhood and preschool students.

**17. Will start and stop time be the same?**

All-Day Kindergarten will follow the following time schedule: 9:00-3:45.

Kindergarten AM: 9:00-11:45

Kindergarten PM: 1:00-3:45

**18. How many students will be in a kindergarten class?**

Our kindergarten through third grade class sizes range from 21-24 students. All Kindergarten classes will be within that range.
